I want to make it clear that if Nicolo Mascitti attempts to assign blame to me regarding any issues at Sican, I have been on maternity leave since February 2024 and have not engaged in any management responsibilities, only holding the position of director in the company Sican Ltd.

Additionally as mentioned in my email from October 24, 2024, Nicolo completely restricted my access to Sican starting in mid-August 2024, and there are still legal proceedings ongoing between Nicolo and me.
