

## APPENDIX B – FEES AND CHARGES SUPPORTING INFORMATION

This report delegates authority for approving fees and charges increasing up to 7% to the relevant Executive Director in consultation with portfolio holders. New fees and charges or exceptions where increases are above 7% on the previous year's maximum level are detailed for Cabinet approval.

Supporting information is provided below to explain the exceptional proposals and the reasonableness of the fee or charge.

### B1 Community Services

#### Green Space

The service is proposing to increase the charge for commemorative benches in Russell Square Gardens by 12.36% to £2,009 (PLA.054) and cast iron end commemorative benches by 12.24% to £2,237 (PLA.054) due to the increase in prices on the supplier side as a result of rising inflation. The increase in the fee is therefore required to maintain cost neutrality for the service offer.

#### Islington and Camden Cemetery Service (ICCS)

The ICCS are proposing to raise their fees and charges by the inflation rise of 10% as a means of ensuring services can meet their growing costs (ICCS.001-ICCS.202). Overall, it is believed that the market will bear price increases of this size given the relatively low level of our current fees compared to local competitors. Residents also continue to benefit from preferential rates.

The board of the ICCS which contains Officers and Cabinet members from both Islington and Camden reviewed the proposals on 3<sup>rd</sup> November and agreed the increases to be put forward for Cabinet approval.

#### Sports & Physical Activities

The service is proposing to introduce a new type of swimming lesson for babies (GLL.266 – GLL.268), discounted teaching pool hire (GLL.269, GLL.270) and a few all-inclusive fees (GLL.271 – GLL.274) which allow unlimited access to leisure centres for a set fee.

### B2 Environment and Sustainability

#### Environment Services

The service is proposing to increase a number of their fees that relate to business waste collection and disposal above 7% (PLA.331 – PLA.398). This is due to a detailed review of costs associated with certain service offers in addition to underlying cost increases of 9% associated with costs such as sack prices, average weekly earnings, and diesel. Fees relating to services, such as, the removal of graffiti, fly-posters and abandoned vehicles, business general waste and recycling disposal, are proposed to increase 10% to ensure the service has flexibility to be able to cover its costs in the current inflationary environment, whilst also ensuring they remain competitive in the open market. As a result of the review, a number of charges will also be removed and new charges which better reflect the cost of services and more specifically define the size and weight of bins will be introduced along with some new service offers. This will lead to savings on smaller bins and an increase for larger heavier collections.

The service is also proposing to introduce new fees (PLA.951 – PLA.954) which relate to fixed penalty notices (FPN) in respect of Community Protection Notices and Public Space Protection Orders (PSPO). The Anti-Social Behaviour Crime and Policing Act 2014 states that £100 is the maximum FPN that can be issued for failure to comply with a Community Protection Notice s.52(7) and failure to comply with a PSPO s68 (6). These penalties will be discounted to £60 if paid within 14 days.

New fees (PLA.902-PLA.950) for the expansion of Refill Station Camden, facilitated by Future Neighbourhoods funding to drive up the Circular Economy greening of spaces, growing and affordable healthier food offerings on the market are also being proposed. Some of these fees and charges include commodities sold on the e-cargo bike stall, such as organic dried spices, teas, herbs, soup mixes and other locally made options. These locally sourced affordable organic food items are evaluated as VAT exempt and the pricing is standardised at £1.20 per jar portion or £2.40 for a scoop or 3 dried soup portions.

## B3 Customer Services

### Contact Camden

Fees and charges in the Contact Camden service relate to street naming and numbering for new developments and changes to existing. The service is proposing to introduce a fee for providing “written confirmation (letter or email) of official address or additional copies of additional notification letters” at a cost of £25. The service occasionally receives requests from search companies to provide address details for residential or non-residential properties in a given location. This is most likely a chargeable service by these companies, for their customers. Such documents are required for Land Registry. Other authorities who already charge for this service are Barnet and Enfield. The £25 charge has been calculated with a view to recovering costs.
