1. Application

1.1 This is an application for a new premises licence under section 17 of the Licensing Act 2003. **Appendix 2**

1.2 The application is for:

a) Supply of Alcohol (For consumption on and off the premises)

Lower Ground Floor

12:00 – 00:00 Monday to Thursday

12:00 - 01:30 Friday and Saturday

Upper Floor

12:00 – 00:00 Monday to Thursday

12:00 - 00:30 Friday and Saturday

First Floor

12:00 – 01:00 Monday to Thursday

12:00 – 03:00 Friday and Saturday

12:00 – 00:00 Sunday

b) Live Music

12:00 – 04:00 Monday to Sunday

c) Recorded Music

12:00 – 04:00 Monday to Sunday

d) Performances of Dance

12:00 – 04:00 Monday to Sunday

e) Anything similar to live music, recorded music or performances of dance

12:00 – 04:00 Monday to Sunday

f) Late night refreshment

23:00 – 04:00 Monday to Sunday

g) Opening hours

12:00 – 04:00 Monday to Sunday

1.3 Following representations made by the Police responsible authority, the application has been amended to include conditions agreed with the Police.

On the basis that the agreed conditions are included in the application, the Police have withdrawn their representation. The agreed conditions can be found at **Appendix 4**.

2. Representations

- 2.1 Three relevant representations have been received in relation to the application.
- 2.2 Three representations oppose the application, and these are from two local resident's associations and one local resident.

- 3.4 The times for the framework hours on any given day are not (and should not be regarded as) the "usual" or "normal" working hours for licensable

activities in the Borough. Instead, the framework hours serve to identify those cases where the Licensing Authority will pay particular regard to the likely effect on the local neighbourhood of carrying out the proposed licensable activities.

Women's Safety (Appendix One – Page 88 to 89 of the Policy)

- 3.5 The Council has adopted a set of principles that commit our licensed premises to act in a responsible manner, taking all forms of female harassment seriously and set out the practical steps licensed premises can take to support this.

- a) Grant the application in full with such conditions on the licence that are consistent with the operating schedule.
- b) Grant the application subject to revised conditions that they consider appropriate to promote the licensing objectives.
- c) Reject the whole or part of the application.

5.3 Members may attach additional conditions if they consider it appropriate for the promotion of the licensing objectives raised in the representations.

5.4 Members are reminded that all applications must be considered on their own merits, and that findings on any issues of fact should be on the balance of probability.

6. Conclusion

6.1 Members are required to consider the application in light of all the relevant information, and if approval is given, may attach such conditions appropriate to promote the licensing objectives.
